The disqualifying misconduct included conduct constituting a crime involving dishonesty or false statement within the meaning 16 17 of Evidence Rule 609(a), to wit: Making a False or Misleading Statement to a Public 18 Servant. RCW 9A.76.175. The misconduct also included conduct constituting a crime 19 committed under the color of authority of a peace officer, to wit: Failure of Duty by Public 20 Officer. RCW 42.20.100. The disqualifying misconduct is as follows: 21 Count I – False or Misleading Statements 22 On or about February 14, 2019, MALPICA engaged in conduct constituting the crime of Making a False or Misleading Statement to a Public Servant when he knowingly 23 24 provided false or misleading material statements to WWUPD Sergeant Lipson regarding 25 contacting and reporting potential criminal activity to the Social Security Administration

and to the Whatcom County Sheriff's Office. RCW 9A.76.175.

2	Count II – False or Misleading Statements
3	On or about July 16 and 25, 2019, MALPICA engaged in conduct constituting the
4	crime of Making a False or Misleading Statement to a Public Servant when he knowingly
5	made false or misleading material statements to internal affairs investigators in recorded
6	interviews. RCW 9A.76.175.
7	AND/OR
8	Count III – Failure of Duty
9	On or between February 8 and 12, 2019, MALPICA engaged in conduct
10	constituting the crime of Failure of Duty when he willfully neglected to perform a lawful
11	order by his supervisor to provide him with specific information regarding potential
12	criminal activity as directed. RCW 42.20.100.
13	
14	The discharge is final and some or all of the acts or omissions forming the
15	basis for the discharge proceedings occurred on or after January 1, 2002.
