STATEMENT OF CHARGES

Respondent.

On or about October 2, 2020, MACKENZIE GREENE, a certified peace officer with the Thurston County Sheriff’s Office, was discharged for disqualifying misconduct as defined by former RCW 43.101.105(1)(d) (2011) and former RCW 43.101.010(8)(a)(i)(B) and (b) (2020). The disqualifying misconduct included conduct constituting a crime involving dishonesty or false statement within the meaning of Evidence Rule 609(a), to wit: Making a False or Misleading Statement to a Public Servant. RCW 9A.76.175. The disqualifying misconduct is as follows:

**Count I – False or Misleading Statements**

On or about August 8, 2020, GREENE engaged in conduct constituting the crime of Making a False or Misleading Statement to a Public Servant when he knowingly provided false or misleading material statements to Thurston County Sheriff’s Office Lieutenant Carla Carter during a conversation regarding the damage to GREENE’S department-issued vehicle. RCW 9A.76.175.

AND/OR

1 **Count II – False or Misleading Statements**

2 On or about August 8, 2020, GREENE engaged in conduct constituting the crime  
3 of Making a False or Misleading Statement to a Public Servant when he knowingly  
4 provided false or misleading material statements to Thurston County Sheriff's Office  
5 Sergeant Mike Brooks during a conversation regarding damage to GREENE's  
6 department-issued vehicle. RCW 9A.76.175.

7 AND/OR

8 **Count III – False or Misleading Statements**

9 On or about August 9, 2020, GREENE engaged in conduct constituting the crime  
10 of Making a False or Misleading Statement to a Public Servant when he knowingly  
11 provided false or misleading material statements to Thurston County Sheriff's Office  
12 Sergeant Malcolm Mclver during a conversation regarding damage to GREENE's  
13 department-issued vehicle. RCW 9A.76.175.

14  
15 The discharge is final and some or all of the acts or omissions forming the  
16 basis for the discharge proceedings occurred on or after January 1, 2002.  
17 Former RCW 43.101.105(1)(d) (2011).
