9 **I. COMMISSION'S CONSIDERATION**

10 A. Default. This matter has come before the Criminal Justice Training
11 Commission ("Commission"), pursuant to RCW 43.101.155(1), WAC 139-06-050(3), and
12 RCW 34.05.440(1). On June 25, 2021, the Assistant Director Kevin Zeller issued a Statement
13 of Charges ("SOC") seeking to revoke Lee Gaskill's peace officer certification based on
14 disqualifying misconduct. The Hearing Coordinator, Kayla Wold, sent the SOC along with
15 the required Peace Officer Certification Request for Hearing Form ("Hearing Request") and a
16 declaration of service to Lee Gaskill ("Respondent") on June 30, 2021, by Certified Mail. The
17 Certified Mail piece was not claimed, and a public notice was also placed on CJTC's webpage.

18 The Respondent did not request an adjudicative hearing within sixty calendar days of
19 service of the SOC and Hearing Request as required by RCW 43.101.155(1) and
20 WAC 139-06-050(2).

21 B. Record Presented. The record presented to the Commission for review and for
22 entry of a final decision included the following:

- 23 1. Statement of Charges *In Re Certification of Lee Gaskill* issued by Kevin
24 Zeller.


1 parties with a written notice specifying the date by which it will act on a petition. An order
2 denying reconsideration is not a prerequisite for filing a petition for review.

3 C. Stay of Effectiveness. The filing of a petition for reconsideration does not
4 stay the effectiveness of this Order. Any such requests should be made in connection with a
5 Petition for Judicial Review made under chapter 34.05 RCW and RCW 34.05.550.

6 D. Judicial Review. Proceedings for judicial review may be instituted by filing
7 a petition in superior court according to the procedures specified in chapter 34.05 RCW, Part V,
8 Judicial Review and Civil Enforcement (RCW 34.05.510 through .598). The petition for judicial
9 review of this Order shall be filed with the appropriate court and served on the Commission, the
10 Office of the Attorney General, and all parties within thirty (30) days after service of this Order,
11 as provided in RCW 34.05.542.

12 E. Service. For purposes of filing a Petition for Reconsideration or a Petition
13 for Judicial Review, service is effective upon deposit of this order in the U.S. mail, declaration of
14 service attached hereto.
