The ACT program is a court security program for both sworn and non-sworn personnel who work in or around a courthouse and is designed to directly enhance attendees' capabilities in advanced threat awareness skills.

Because courthouses are vulnerable to acts of random violence, they must have proper court security procedures. These procedures ***protect the safety*** of the visitors, staff, and property within and around the courts and maintain the ***integrity of the judicial process***. Many current security training programs focus on reactive versus proactive solutions. This course is the opposite, focusing on proactive safety measures that can ***prevent violence***.

Attendees will learn to use a proactive approach to observe and identify courtroom threat indicators, establish baselines in their environment, and how to recognize certain anomalies that indicate potential threats through human behavior, body language and environmental awareness. This course can assist agencies in reviewing or forming new protocol that creates a safer environment.
