

The Office of Administrative Hearings (OAH) scheduled this matter for a prehearing conference before Administrative Law Judge Laura Bradley on July 26, 2024 at 10:00 AM. On July 24, 2024, the Respondent Representative requested a continuance for the following reasons: Pending Legal Matter. Respondent is moving for a new trial in criminal case. The motion is scheduled to be heard on August 13, 2024. This matter is continued until the respondent knows whether a new trial will be granted.

TO PARTICIPATE:

1. To participate, call **1-866-527-0393** at the time specified above.
2. When prompted, enter **996 094 593, followed by the # key**. You are not the Meeting Organizer so do NOT press the * key if asked to do so.
3. You will be placed in the “lobby” awaiting the Judge to begin the event (you may hear “Hold” music).
4. Please announce yourself as you join. Make sure your phone has reception and is charged to last the length of the mediation, and that you are in a quiet place where you can hear and be heard clearly.
5. If you have problems joining the telephone conference, or if the judge does not join within ten minutes after the Prehearing Conference start time, immediately call OAH at (253) 476-6888. If you get disconnected, call back in using the same phone number and access code listed in Steps 1 and 2 above. If you have trouble getting reconnected to the telephone conference, call (253) 476-6888 immediately for help.

You must call in to the prehearing conference. If you fail to call in, the administrative law judge may hold you in default and dismiss your appeal.¹

If you are unable to call in, you may request a continuance. A continuance request must give a reason. OAH will only grant your request for continuance, if your reason provides good cause. Please send your request to the assigned administrative law judge at:

You may also send your request to the assigned administrative law judge electronically via the OAH Portal or by secure email. You must send a copy of your request to everyone listed on the Certificate of Service. If the request is urgent, call (253) 476-6888. You must call in unless OAH notifies you that the prehearing conference is continued.

You may be represented by an attorney or other representative at your own expense.² If you need an interpreter, we will provide one at no cost. If you have a disability and need accommodation, we may be able to help. Please contact OAH at (253) 476-6888 to request an interpreter or accommodation.


