Dear Esteemed Stakeholders:

Since the October 2024 temporary prohibition of Sig Sauer's P320, M17, and M18 firearms, the Washington State Criminal Justice Training Commission (WSCJTC) established a workgroup, who reviewed numerous reports of un-commanded discharge incidents and civil proceedings involving Sig Sauer's P320, M17, and M18 firearms. The WSCJTC workgroup, consisting of criminal justice agency stakeholders, firearms industry representatives, Sig Sauer representatives, and WSCJTC staff, met to discuss the array of publicly sourced information and court filings, resulting in the production of a report (attached), which guided me in making my final determination.

After reviewing the report and associated records, and carefully considering the safety of our staff, students, and guests, I found sufficient information to prohibit the current Sig Sauer P320, M17, and M18 firearms from all properties owned or leased by the WSCJTC, indefinitely.

- ***This prohibition includes all WSCJTC sponsored training and special event facilities (owned or leased).***

As the Executive Director of the WSCJTC, I empathize with the budgetary impacts of this decision, but must prioritize the safety of every person working, training, or visiting WSCJTC by continuing this prohibition. In accordance with WSCJTC's commitment to transparency, I have attached the report, with imbedded links, to the content I reviewed, and upon which relied, in reaching this decision.
