## **Training Requirements:**

Agencies are expected to provide ACADIS training reports to meet the training requirements listed below. For some of the requirements, the requisite courses are still in development by CJTC. In those cases, agencies are required to submit an attestation that your agency will meet the requirements on a schedule to be agreed upon with the HB 2015 Program Manager and WSCJTC's Executive Director:

#### 1. Violence De-Escalation & Mental Health

- 100% Officer completion of the WSCJTC's Annual CIT Online Course for either the current year or previous year in accordance with RCW 43.101.427.
- Agencies can enroll their officers in online courses using these instructions.

## 2. Law Enforcement Training and Community Safety Act (LETCSA) Training

In accordance with Sec 3.b and LETCSA 139-11-020, a 50% completion rate is required. If your agency has not yet achieved a 50% completion rate, you can meet this requirement by providing a detailed training plan to meet the training requirements on a schedule to be agreed upon by the agency and WSCJTC.

To complete the requirement, an officer must complete 40 hours of training to include:

• #2194 (formerly #2192) Patrol Tactics in Service, Violence and De-Escalation

And 16 total training hours selected from the following ACADIS courses:

- #4000 Who are the Sikhs?
- #4010 Law Enforcement and Society: Lessons of the Holocaust.
- #4020 The United States Criminal Legal System: Structural Inequalities, Monetary Sanctions, Policy and Reform.
- #4030 Effective Communication.
- #4040 LGBTQ+ Core Competency.
- #4050 Introduction to the Historical Intersection of Race and Policing.

- #4070 People First: Awareness, Challenges, and Response to Poverty and Recidivism.
- #4080 Understanding the Diversity and Complexity of Asians and Asian American Communities.
- #4090 Introduction to Indigenous Concepts and Culture.

Note: An agency's 50% completion rate in both categories does not necessarily meet compliance. An officer must complete all 40 hours of training to count towards the 50% completion rate.

#### 3. Use of Force

At least one officer with completion in both of the following "Train the Trainer" courses in accordance with the AG's Model Policies on Use of Force:

- 6240 Use of Force/Control Defensive Tactics Instructor Course.
- 6241 LEAD Use of Force/Control Defensive Tactics Instructor Course.

#### 4. 40-hour Crisis Intervention Team

• 25% officer completion rate with the WSCJTC's 40-hour crisis intervention team training.

#### 5. Sexual Assault and Gender-Based Violence

100% officer compliance rate for investigators required to complete trauma-informed, gender-based violence interviewing, investigation, response, and case review training developed or approved by the WSCJTC pursuant to RCW 43.101.272 and if requested by WSCJTC, participated in agency case reviews.

 7100 - Sexual Assault Investigations: Victim-Centered Resiliency Engagement Tactics (Detectives).

#### 6. Sexual Assault and Gender-Based Violence

By RCW 43.101.276, agencies must attest that their officers and patrol officers will complete the following trainings within one year of July 1st, 2026:

- 7260 Sexual Assault Investigations: Patrol Officer Response to Sexual Assault (Patrol Officers).
- 7250 Start by Believing (All Officers).

# 7. Roster Identifying Officer Status

To confirm the criteria in requirement #5, agencies must submit a roster identifying their detectives and investigators.
